



**TERMS AND CONDITIONS (“T&C”) OF PROVINCIAL DEPOSIT CAMPAIGN  
“OPEN & REWARD”**

1. The campaign starts from 01<sup>st</sup> July 2021 until 31<sup>st</sup> January 2022.
2. This campaign is open to:
  - a) **New Customers (NTB)** – who open any Saving and Current Account (CASA), Current Account Advantage (CAA), Premier Current Account (PCA), and Fixed Deposit (FD) of 3, 6, and 12 months’ tenure with RHB Bank only with campaign period.
  - b) **Existing Customers (ETB)** – who top-up (new fund) to their existing Saving and Current Account (CASA), Current Account Advantage (CAA), and Premier Current Account (PCA) with RHB Bank only in campaign period.
