

“RHB Premier Customer(s)”

1. The RHB Bank (Cambodia) Plc. (Company No. 00001812) will be referred to as “RHB”.

TERMS AND CONDITIONS FOR RHB PREMIER CUSTOMER(S)

All RHB Premier Customer(s) shall be bound by the Terms and Conditions herein. In these Terms and Conditions, “RHB Premier Customer(s)” refers to a sole customer of the Bank or collectively, two or more joint customers of the Bank, who has/have applied for RHB Premier Customer(s) and whose application has been accepted by the Bank.

RHB Premier Customer(s) Privileges and RHB Premier Customer(s) services shall be governed by the Terms and Conditions applicable to each such service.

RHB Premier Customer(s) Privileges and RHB Premier Customer(s) services are also bound by the terms and conditions stated in the “Terms and Conditions for Accounts and Related Services (For Individuals)”, (collectively “Terms and Conditions for Accounts”). For Packaged Banking Service, in the event of any inconsistency between these Terms and Conditions and the “Terms and Conditions for Accounts”, these Terms and Conditions shall prevail.

1. RHB Premier Customer(s)

- a. RHB Premier Customer(s) is subject to a monthly review at the Bank’s discretion.

2. Termination of RHB Premier Customer(s)

- a. RHB Premier Customer(s) or in the case of joint RHB Premier Customer(s), any one of them may terminate their RHB Premier Customer(s) by giving the Bank a written notice.
- b. All RHB Premier Customer(s) Privileges accorded to RHB Premier Customer(s) shall be terminated forthwith upon his/her death or bankruptcy. In the case of joint RHB Premier Customer(s), the Bank may at its discretion terminate or continue to accord all privileges to the surviving RHB Premier Customer(s).
- c. RHB Premier Customer(s) is extended to the RHB Premier Customer(s) at the Bank’s discretion and the Bank may cancel RHB Premier Customer(s) at any time without any obligation to give RHB Premier Customer(s) any notice or reasons.

3. Change of Address

- a. RHB Premier Customer(s) shall promptly notify the Bank in writing of any changes in his/her/their address.
- b. In addition, RHB Premier Customer(s) shall also promptly notify the Bank in writing on any change of his/her/their current employment and/or office address.

4. Indemnity

- a. RHB Premier Customer(s) shall fully indemnify the Bank against all costs and expenses (including legal fees on an indemnity basis) incurred by the Bank in enforcing these Terms and Conditions and the recovery of any amounts due to the Bank or incurred by the Bank in any legal proceedings of whatever nature. Where RHB Premier Customer(s) is extended to two or more customers, they shall be jointly and severally liable for any liabilities incurred herein.

5. Waiver

- a. No forbearance, neglect or waiver by the Bank in the enforcement of any of these Terms and Conditions shall prejudice the Bank’s right thereafter to strictly enforce the safe.

6. Amendment of Terms and Conditions

- a. The Bank shall at its discretion amend, add or delete the Terms and Conditions herein without prior notice to RHB Premier Customer(s).

7. Governing Law

- a. These Terms and Conditions shall be governed by and construed in accordance with Cambodia Laws.
